Supplementary Regulations

1. This is a National B Sporting Trial held under the general regulations of the M.S.A. Ltd. incorporating the provisions of the International Sporting Code of the F.I.A. these supplementary regulations and any other written instructions the promoting club may issue.
2. M.S.A. permit no.TBA has been applied for
3. The event is a qualifying round for the M.S.A British Sporting Trials Championship (Waiver Permit No. 2014/S/0500, the BTRDA Sporting Trials Championship and The BTRDA Allrounders 2014 Championship supported by REIS (67/2014)
4. The trial is open to all members of the promoting club, B.T.R.D.A. and Northern Phoenix Trials Car Club. Other Clubs can be invited at the organisers' discretion. All competitors must be in possession of a current M.S.A. Licence or Club membership card appropriate for this type of event, which must be produced for inspection at signing on. All passengers must be a member of one of the above clubs.
5. The Trial will be held near, Eaton, Lincolnshire, a short distance west of the village on the unclassified road leading to Stathern and Eastwell.
The nearest postcode is NG32 1SW the site is 500 m South East of this farm.
The map ref. is SK 790292
6. PROGRAMME
Scrutineering opens at 09.00.
Signing on opens at 09.00.
Any competitor not signed on by 10.15 may be excluded.
First car starts 10.30.
7. There will be three classes, Red, Blue and Green, competitors will be classified according to the BTRDA Formula.
8. Tyre pressures will be a minimum of 2 PSI. This may be altered according to site conditions, at the discretion of the Clerk of the Course. Tyre pressures will be checked at scrutineering, spot checks may be made during the day.
9. All rear tyres must be one of the following Toyo 330, Vredestein T-Trac, Firestone F560, Vredestein Sprint or Michelin XZX.

10. Entries will not exceed 45 and there will be a minimum entry of 20. Double drives will be accepted up to a maximum of 10 entries.
11. Closing date for entries is Wednesday 19th November 2014. Entries should be made on the official entry form and sent to the Secretary of the Meeting, accompanied by the entry fee.
12. The entry fee is **£35.00** for all entries received before Sunday 16th November.

For entries accepted after this date the entry fee is £40.00.
