ADDITIONAL SUPPLEMENTARY REGULATIONS

- 1) The Lancashire & Cheshire Car Club Ltd. will organise a National B status Sporting Trial on Sunday 22nd April 2012 at Averillside Farm, Warslow, Nr. Buxton, SK17 0LW.
OS Map Reference: 063597
- 2) The meeting will be held under the General Regulations of the Motor Sports Association Ltd. (incorporating the provisions of the International Sporting Code of the FIA), these Supplementary Regulations and any written instructions that the organising club may issue for the event.
- 3) MSA Permit No: 69522
- 4) The event is open to: a) All fully elected members of the organising club and
b) Members of the following clubs or championship: BTRDA; Registered contenders for the British Championship; Midland Auto Club; SUNBAC; Sheffield & Hallamshire M.C.; Mid-Cheshire M.R.C; Yorkshire Sports Car Club.
- 5) All competitors and drivers must produce a valid Competition Licence, Club Membership Card and/or Championship Registration Card.
- 6) The event is a round of the BTRDA Trials Championship and the British Sporting Car Trials Championship (permit 2012/S/0500) and the REIS BTRDA Allrounders Championship 2012.
- 7) The programme of the meeting will be: Scrutiny starts at **9.00** a.m. Any competitor not signed on by 10.20 a.m. may be excluded. First car starts at 10.30 a.m.
- 8) Public roads will not be used to link sections. There will be at least 3 runs at 9 sections on private land. Details of the tests will be issued at signing-on. The start will be at Averillside Farm. Map reference 119/063597.
- 9) The event will consist of three classes as under.
 1. Red Class: Drivers who have won outright any two BTRDA Championship Trials in the previous five years.
 2. Blue Class: Drivers not qualifying in the Red Class, but who have finished in 12th place or above in any Championship Trial with a minimum of 20 finishers in the previous five years.
 3. Green Class: Drivers not qualifying for either the Red or Blue Class.
- 10) Awards will be presented as follows: (Named awards will be tenable for 11 months)
 - a) Best performance of the day: The Kukla Brewer Trophy.
 - b) 1st in each class: A Named Award.
 - c) 2nd in each class: An Award.

11) The entry list opens on receipt of these ASRs and closes finally on Wednesday, 18th April 2012. The entry fee is £35.00. All entries must be made on the official entry form and accompanied by the appropriate fee.

13) The maximum entry for the meeting, including reserves, is 75. The minimum is 20.

Should the above minimum figure not be reached, the organisers have the right to cancel the meeting. Entries will be selected as follows: In order of receipt. The Secretary will make a draw for starting numbers. Entry fees may be refunded if notification of cancellation is received by the Secretary before April 21st 2012.

14) The officials of the meeting are: Clerk of the Course, Phill Matthews;
Assistant : Phil Whatmough, Chief Marshal, Mr. W Holme, Club Steward, Mr. R Grant;
Scrutineer, Mr. R.O'Neil

15) Provisional results will be published as soon as possible after the end of the event

16) Any protest must be lodged in accordance with C (d) 45-59

17) Starting numbers will be issued at signing on. Competitors will be identified by numbers which will be provided by the organisers

18) Marking and penalties will be as printed in the appropriate section of the MSA General Regulations.

19) All other General Regulations of the MSA apply as written.

20) The organising club reserves the right to alter the number of tests and/or runs according to the weather conditions and time available on the day.

21) Drivers must move on 3 hills at the start of each round.

22) Minimum tyre pressures will be 2psi. Checks will be made.

23) Shared/Double drives will be permitted.

24) Only Vredestein Sprint+ and Firestone F560 tyres are permitted.
