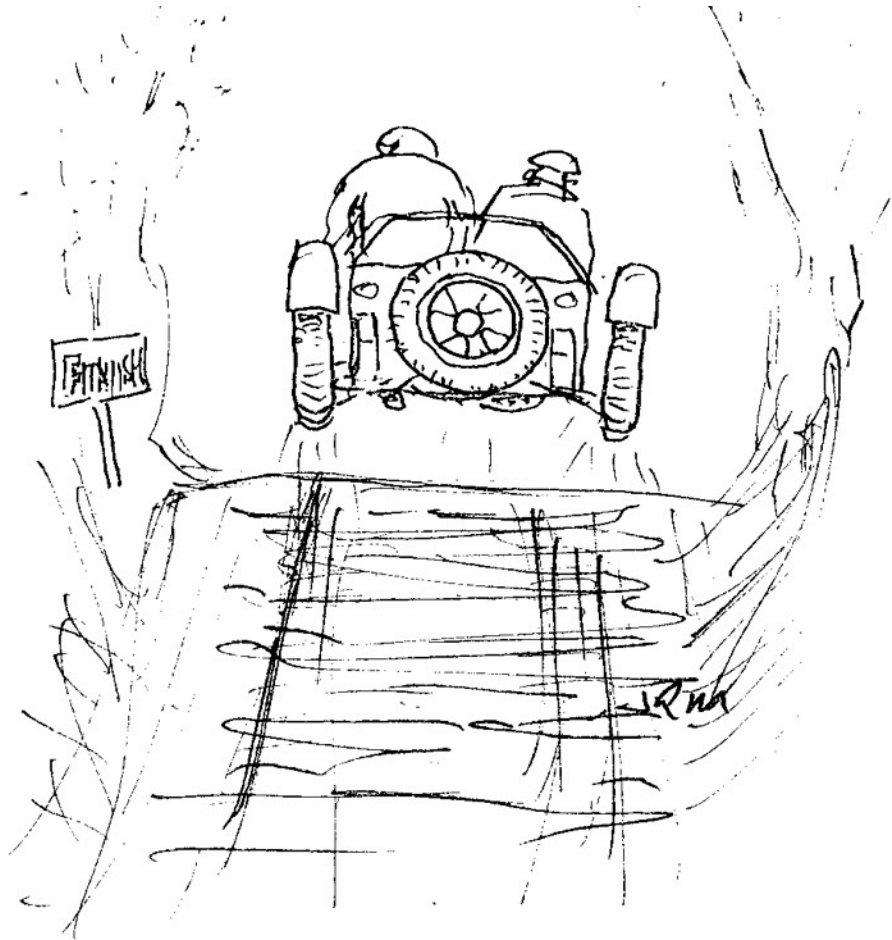

SUPPLEMENTARY REGULATIONS

- 1 The Southsea Motor Club Ltd will organise a combined National B and Clubmans Sporting Trial at Bordean Lane, Froxfield Green, Nr Petersfield, Hants, GU32 1DJ (map reference 197/SU704249) on Sunday 24 March 2019. The event will be jointly promoted by Southsea Motor Club Ltd and 750 Motor Club.
- 2 The meeting will be governed by the General Regulations of Motorsport UK (incorporating the provisions of the International Sporting Code of the FIA), these SRs and any written instructions the organising clubs may issue for this event.
- 3 RAC MSA permit numbers:- National B: 111818 Clubmans: 111817
- 4 The event is open to all fully elected members of the organising clubs or members of one of the following invited clubs:-
BTRDA, SportingTrials.com., Kentish Border, VSCC, HSCC, MCC .

The event counts towards the 2019 BTRDA Sporting Trials Championship, The 2019 Motorsport UK British Sporting Car Trial Championship (2019/S/0500), The 2019 ASWMC Sporting Trials Championship (permit no 38/2019), The BTRDA Allrounders Championship (permit no 004/2019) and the 750 Motor Club Sporting Trials Championship.

Clubmans drivers must produce a valid membership card from the organising clubs or one of the invited clubs. **National B** drivers must produce a valid competition license and valid membership card from the organising clubs or one of the invited clubs. All passengers to National B drivers must produce a valid membership card from the organising clubs or one of the invited clubs.

- 5 Public roads will not be used to link the sections. There will be 3 rounds of at least 8 sections on private land. The entry will be split into groups, starting at different hills to enable the programme to be completed.

- 6 All cars will comply with Motorsport UK technical regulations and with the Motorsport UK National Trials Formula or the 750 MC Trials Car Formula – as applicable.
- 7 Awards will be presented as follows:-

Best performance of the day
Best performance in Independent Red Class
Best performance in Independent Blue Class
Best performance in Live Axle Red Class
Best performance in Live Axle Blue Class
Best performance in Rookie Class
Best performance Clubmans Class

Any perpetual trophies to be returned to Southsea Motor Club by end of February 2020.

- 8 The entry list opens on publication of these SRs and **closes on Tuesday 19 March 2019.** Entry fee is **£45 for National B entries, £38 for Clubmans entries.**

Entries, if submitted by post, must be made on the official entry form and accompanied by the appropriate fee. Entry fees will be refunded if the Secretary of the Meeting is notified of a competitor's cancellation by 12 noon on Friday 22 March 2019.

Entries submitted electronically should be completed on line and emailed to the Secretary of the Meeting by **Tuesday 19 March 2019**.

13 Competitors will be identified by numbers provided by the organisers.

14 All other GRs of the RAC Motorsport UK apply as written except 5.3.4: the running order will not be reversed during the event.

15 Starting numbers will be allocated by ballot.

16 All competing cars must be fitted with an effective silencer

17 **Tyres: Nat B and Clubmans** – any tyres listed in 2018 Blue Book Sect L, List 3 complying with relevant championships.

18 No person may drive a competing car on the site except the authorised competitor.

19 **All dogs must be on leads, this is a shooting estate.**
