## **Supplementary Regulations**

- 1. The Kentish Border Car Club will organise a National B permit Sporting Trial at Tulleys Farm, Turners Hill, RH10 4PD on Sunday 3rd November 2019
- 2. The Meeting will be governed by the General regulations of the Motorsport uk (Incorporating the provisions of the International Sporting code of the FIA), these SR's and any written instructions the organising club may issue for the event.
- 3. Motorsport uk Permit number: 114876
- 4. The event is open to all fully elected members of the organising club and members of the following invited clubs: B.T.R.D.A, NPTCC, 750 MC, MTCC, L&NCMC, Camel Vale MC, Bristol MC, holding an Motorsport uk Competition License valid for the event. Club membership cards and competition licences, with drivers photograph attached will be inspected at signing on.
- 5. The event is a round of the 2019 motorsport uk Sporting Trial Championship, the 2019 B.T.R.D.A. Sporting Trial Championship, sponsored by Tulleys Farm and the 750MC Sporting Trials Championship.
- 6. The event will be at Tulleys Farm, Turners Hill. Public Roads will not be used to link sections. There will be 6 to 8 tests on private land to be attempted 3 or 4 times. The entry will be split into groups starting at different hills to enable the programme to be completed.
- 7. Scutineering starts at 9-00 am. First test at 10-30 am.
- 8. Awards to be presented as follows:

Best overall performance of the day: Driver and Passenger.

Best Performance Red Class. Independent and Live

Best Performance Blue Class Independent and Live

Best Performance Rookie Class
