## THE IVINGHOE SPRING TRIAL

### Sunday 14<sup>th</sup> April 2019

#### ADDITIONAL SUPPLEMENTARY REGULATIONS

1. Falcon Motor Ltd. will organise and promote a National B and Clubmans dual permit Car Trial on Sunday 14<sup>th</sup> April 2019 at Ivinghoe Aston Farm, Near Ivinghoe Aston Beds LU7 9DG.  
Map reference: - 165/958176.
2. The meeting is held under the General Regulations of Motorsport UK. (incorporating the provisions of the International Sporting Code of the FIA), these supplementary regulations and any written instructions that the organising Club may issue for the event.
3. The event will be held under dual permits; Motorsport UK Permit Nos: 111840 (National B) & 111838 (Clubmans)  
The National B event is a round of:  
Motorsport UK British Car Trial Championship (Championship Registration no. 2019/P/0600);  
A qualifying event for the BTRDA Car Trials Championship and the BTRDA Allrounders Championship (Championship Registration no. 2019/004).  
**Contenders in the above championships must enter the National B event.**  
The Clubmans event is a round of:  
The AWMMC Car Trial Championship and the ASEMC Car Trial Championship  
**Contenders in above championships should enter the Clubmans event, but if also entering any of the National B championships, their National B entry will qualify for these championships.**  
The event is also a round of the: AMSC 2018/19 Trials Challenge.
4. **The National B** event is open to fully elected members of the organising Club, plus members of the following invited Clubs and Associations: - BTRDA, registered contenders for the Motorsport UK British Car Trial Championship, BTRDA Car Trial Championship and the BTRDA Allrounders Championship
5. **The Clubmans event** is open to entrants for the AWMMC Car Trial Championship and the ASEMC Car Trial Championship and. all fully elected members of the organising Club plus the member clubs of the Anglia Motor Sport Club, The Motor Cycling Club Ltd., Sevenoaks & District MC, The Vintage Sports Car Club, MG Car Club, Bedford CC.
6. All National B event competitors must produce a valid Club membership card and relevant Competition Licence for the event.  
Drivers in the Clubmans event must produce a valid Club Membership Card.  
All National B passengers must produce a valid club membership card.  
Junior drivers **MUST** have parent/guardian permission to take part in the event.
7. The programme of the meeting will be: -  
Signing on starts at 8:30am - followed immediately by scrutineering  
Any competitor not signed on by 9:45am may be excluded. First car starts at 10:00am.
8. Public roads will not be used to link sections. There will be at least 6 sections on private land and up to 4 runs at each section, weather permitting. The entry may be split into groups starting at different sections.
9. A front seat passenger is not mandatory but may be required depending on individual championship regulations. The AMSC Championship requires a passenger - If a passenger is carried, then that passenger must be carried for the whole event. If a passenger is not carried the driver must be 17 years of age or older and hold a full RTA driver's licence for cars. A passenger with an RTA licence must be seated alongside any driver who is under 17 years or does not hold an RTA licence - in this case the passenger must also produce a valid Club Membership Card of an invited club and be experienced in car trials. (T4.1, T4.1.3)  
  
Competitors shall indicate on the entry form whether they will be carrying a passenger or not.  
Any competitor competing in the AMSC Trials Challenge must carry a passenger in the seat alongside the driver.

10. Due to ground conditions tyre pressures may be altered on the day.

11. All cars must comply with Motorsport UK Technical Regulations T9.

## **12: National B Event:**

### **Classes and Tyre Pressures.**

#### **CLASS 1 - 2 WD PRODUCTION CARS - CARRYING NO BALLAST**

2-wheel drive production cars, first registered on or after 1st January 1998, taxed for road use, carrying no ballast and with no modifications save as follows:

- a) the fitting of under body protection weighing no more than 10kg (including fittings)
- b) the replacement of wheels in accordance with Motorsport UK Regulation T11.12
- c) the replacement of tyres in accordance with Motorsport UK Regulation T11.12.5

Minimum tyre pressures on driven wheels: (see Notes 1 & 2 below)

FWD cars up to 1200 cc: 12 psi  
up to 1400 cc: 14 psi  
over 1400 cc: 16 psi

FE RWD: 12 psi

RE cars: 20 psi

#### **CLASS 2 - FWD PRODUCTION CARS**

Front wheel drive production cars not eligible for Class 1.

Minimum tyre pressures on driven wheels: (see Notes 1 & 2 below)

up to 1200cc: 12 psi  
up to 1400cc: 14 psi  
over 1400cc: 16 psi

#### **CLASS 3 - RWD PRODUCTION CARS (not eligible for Class 1).**

All cars must have an overall first gear ratio which is numerically less than 17:1.

Minimum tyre pressures on driven wheels: (see Note 1 below)

FE Sports cars up to 1800cc: 16 psi      FE Sports cars over 1800cc: 22 psi  
FE Saloon Cars up to 1800cc: 14 psi      FE Saloon Cars over 1800cc: 20 psi  
RE cars up to 1000cc: 22 psi      RE cars over 1000cc: 26 psi

#### **KIT CARS AND MODIFIED PRODUCTION CARS**

All cars to be 2WD and have an overall first gear ratio numerically less than 17:1

Front engine Production Kit Cars to approved Motorsport UK specification (Regulation B).

Front engine Kit Cars modified beyond Regulation T11 and modified up to the limits specified in T10 class 7 (c) and complying with Motorsport UK Regulation T10 (except for T10.1 – MoT not required off road) and with the ACTC approved specification (written evidence of such specification to be produced on demand to any event or eligibility official or championship representative).

Modified Production Cars (not eligible for Classes 1 or 2) complying with Motorsport UK Regulation T10 (except for T10.1 – MoT not required off road) and modified no further than the limits specified in Regulation T10 [Classes 1-6]).

Minimum tyre pressures on driven wheels: (see Note 1 below)

FWD cars: 16 psi  
FE RWD cars: 22 psi  
FE Kit cars: 24 psi  
RE cars: 26 psi

#### **Class 8 - NON-PRODUCTION CARS**

(2WD Cars modified beyond Regulations T11 and modified no further than the limits specified in T10 Class 8 and complying with Regulation T10.) (except for T10.1 – MOT not required off road)

Cars in this class will not be eligible for an overall placing (Index of Performance).

Minimum tyre pressures on driven wheels: (see Note 1)

FWD cars: 22 psi  
FE Kit cars and RE Cars: 26 psi  
FE RWD cars to ACTC specification: 22 psi

Note 1. Any car fitted with a torque biasing differential or any other form of mechanical traction control as catalogued for that car will have tyre pressures set at 4 psi above the specified class pressure. Any car fitted with an unmodified original equipment electronic traction control system will be allowed without the 4 psi tyre pressure penalty.

Note 2. Cars with an overall length of 166 inches and over in classes 1 and 2 may reduce tyre pressures by not more than 4 psi, subject to an absolute minimum pressure of 12 psi.

Note 3. For Championship scoring purposes, Classes cannot be amalgamated.

Note 4. Classes and tyre pressures are consistent with those of the 2018 Motorsport UK British Car Trial Championship.

**13. National B Event Awards** will be presented as follows:

First Overall on Index.  
First in Class subject to 3 starters  
Second in Class subject to 8 starters  
Third in Class subject to 12 starters  
Best Novice and Best Junior across both events as listed under the “Clubmans Event Awards”.

No competitor may win more than one award.

**Index of performance for the National B event** will be calculated in accordance with T7.3.4 – 7.4.2

**14. Clubmans Event:** Classes and Tyre Pressures

**Class 1** – 2-wheel drive production cars, first registered on or after 1 January 1998, taxed for road use, carrying no ballast, and having no modifications save as follows:

- (a). the fitting of a sump guard weighing no more than 10kg (including fittings);
- (b). the replacement of wheels in accordance with regulation T11.12;
- (c). the replacement of tyres in accordance with regulation T11.12.5.

A current MOT certificate must be produced at scrutineering. Exemption can only be given to vehicles less than 3 years old, and then proof of date of first registration will be required.

Minimum tyre pressures on driven wheels (see notes 1 & 2)

FWD cars 14 psi                      FE RWD cars 12 psi                      RE RWD cars 22 psi

**Class 2** – Front wheel drive production cars – 14psi

**Class 3** – Rear wheel drive production cars – FERWD 16psi, RERWD 22psi

**Class 4** – Modified Production Cars and Kit cars and those cars not qualifying for Class 1, 2 or 3 - 20psi

(ref. '2018 Blue Book' T11 Class 1, 2, 3 and 4 for detailed extract)

**15. Clubmans Event Awards** will be presented as follows on least points scored: -

1st Overall  
1st in each class (subject to 3 starters)  
2nd in each class (subject to 5 starters)  
3rd in each class (subject to 8 starters)  
Best Novice (subject to 3 starters in both events)  
Best Junior (subject to 3 starters in both events)

No competitor may win more than one award.

**16. Tyre/technical Regulations:**

The following Motorsport UK Regulations apply to all National B/Clubmans classes

T11.12.6 Use of the following tyres is prohibited: -

- (α) those having any of the following patterns, inscriptions or manufacturers' designations: - 'All Seasons', 'Winter', 'Grip', 'Snow', 'Special Use', 'Town & Country', 'Mud & Snow', 'M+S', 'M.S.', 'M&S', or the Three Peaks Mountain Snowflake symbol;
- (β) those constructed primarily for off-road use;
- (χ) those having additional grooves intentionally cut into the tread pattern (post manufacture);
- (δ) Goodyear All Weather Steel Radial, Goodyear Vector, Pirelli P7, Michelin XRN or Uniband Rally Steel

T11.12.6.1 Tyres must comply with Regulation L 2.1.

Motorsport UK Technical Regulations are covered under: T9 – T9.8.4 & T11.6 – 11.14.4 and must be adhered to.

**17.** Classification of a vehicle will ultimately be at the discretion of the organisers.

**18.** The entry list opens on the publication of these regulations and closes on:  
Wednesday 10th April 2019.

**National B Event**

**Clubmans Event:**

Entry fee for drivers under the age of 18:	£5.00 (National B or Clubman)

Note 1: A refund will only be given if entry is withdrawn before Wednesday 10th April – subject to a £1.90 admin fee for PayPal entries.

Note 2: The Maximum entry for the event is 50 – the minimum is 20 - *Entries will be accepted in order of receipt.*

**22.** Any protests must be lodged in accordance with *regulation C5.1 – C5.7.*

**23.** Marking Penalties are printed in the appropriate section of Motorsport UK regulations.

**24.** Starting numbers will be issued at signing on. Competitors may be required to start at different hills at the beginning and after the lunch break. Running order will be by number in class and after lunch the running order in class will be reversed - During the event competitors **MUST** keep in numerical order as directed by the Clerk of the Course.

**25.** Publication of results – Following a protest period of 30 minutes results will be declared final.

**26.** The organisers may include sections which are timed, have split routes, have different starts, and have restart sections or other tests of a similar nature.

**27.** All other general regulations of Motorsport UK apply as written, except that, as the event takes place on private land vehicles need not be registered, licensed or have a current MOT (if required), excepting for classes 1 and A.

**28.** Toilet facilities will be available on the site. A caterer will be present – please support them.
