## Gloucester Sporting Trial 2019

### Supplementary Regulations



1. Midlands Trials Car Club will organise a National B and Clubman's Sporting Trial at Frocester, Nr Stroud, GL10 3TP on Sunday 1<sup>st</sup> December 2019.
2. This meeting will be held under the General Regulations of the Motorsport UK (incorporating the provisions of the International Sporting Code of the FIA), and these Supplementary Regulations.
3. MSA Permit No. (National B **112693** & Clubman's **112688**) have been issued.
4. The event is open to all fully elected members of the organising club and BTRDA, NPTCC, 750 Motor Club, Southsea Motor Club, Kentish Border, Camel Vale Motor Club, Launceston and North Cornwall, Ross and District Motor Club, Coventry and Warwickshire Motor Club, Peterborough Motor Club, Bristol Motor Club, Loughborough Car Club and Midland Automobile Club.
5. All entrants in the National B event must produce a valid Competition licence; all entrants in the Clubman's event must produce a valid club membership card, at signing on.
6. The National B event is a qualifying round of the Tulleys Farm BTRDA Sporting Trials Championship, the Motorsport UK British Sporting Trials Championship and The 2019 BTRDA Allrounders Championship supported by REIS.
7. Scrutineering starts at 9.00am, situated near signing on.
8. First hill at 10.15am. Any competitor not signed on by 10.00am may be excluded.
9. The trial will consist of three or four rounds of at least six hills. The entry will be split into groups starting on different hills. Start hills will be determined by ballot. No practicing allowed. Competition numbers will be issued by the organisers. Double drives are permitted.
10. Awards will be presented as follows, subject to a minimum of four starters in each class. Organisers reserve the right to reallocate awards:
  - 1<sup>st</sup> Overall
  - Best performance by an MTCC member
  - 1<sup>st</sup> in Independent Red
  - 1<sup>st</sup> in Independent Blue
  - 1<sup>st</sup> in Live Axle Red
  - 1<sup>st</sup> in Live Axle Blue
  - 1<sup>st</sup> Rookie

1<sup>st</sup> Clumban's  
1<sup>st</sup> in Post Historic class

11. The maximum entry for the meeting is 50; if entries exceed this number, entries will be accepted on a 'first come, first served' basis. The minimum is 20, should the minimum number not be reached the organisers reserve the right to cancel the event.
12. The entry list opens on the publication of the S.Rs and closes at 23.59pm on Thursday 28<sup>th</sup> November. Entries must be completed on an entry form and accompanied by the correct entry fee. Entries will be refunded in full with 24 hours' notice or cancellation of the event.
