# **Introduction**

This event will be run to the Motorsport UK 'Restart Motor Sport' guidelines. You will need to be prepared to adhere to these regulations and Government guidelines. If the procedures have eased between the publication of these event regulations and the event date, you will be notified of any relaxation in the Final Instructions. Please do NOT assume that this easing will happen automatically.

Ross and District Motor Sports welcomes you to the **WYE VALLEY** Trial.

We are back at our peaceful and picturesque Putley site at Hill Farm, which offers a fair variety for the Clerk of the Course to set different challenges on different hills. Full directions and suggested routes to the venue will be included in the Final Instructions.

The event is a round of the Motorsport British and the BTRDA National Championships, and the regional West Midland, Welsh and South Western Association Championships in 2019. Also, as usual, it is a round of the Cotswold Motor Sport Group Championship.

You must enter electronically by completing the form on-line via the Club's website. You will then need to pay for the entry by BACS transfer or PayPal following the link on the Wye Valley page on the website. Full details are in ASR 10 of these regulations.

The Organisers

Please be aware that due to Covid-19, this will be a paper-free event.

All correspondence, entry forms, payments and documentation will be by email and carried out prior to the event. Your attention is drawn to the following pages which set out the organisers' provisions to comply with Motorsport UK guidance relating to COVID -19. These provisions are subject to review and will be confirmed or amended as appropriate prior to the start of the event or as deemed appropriate at the organisers' absolute discretion up to the end of the event.

## **COVID-19 Summary of requirements**

In order to run the event safely in the current circumstances, it has been necessary to introduce a number of changes for the safety of the competitors, marshals and organisers. These regulations have been compiled using the Motorsport UK Guidelines and Government Regulations as at the time of writing. A summary of the measures introduced are:

#### **BEFORE** the Event

A requirement that competitors don't enter if they, or anyone that they have been in contact with, have displayed Coronavirus symptoms in the 14 days prior to the event and to sign a declaration to that effect.

If you are in a vulnerable category or have been asked to self-isolate please do not enter.

If you, or anyone you are in contact with, are unwell before the event, you do not attend.

If you live in an area with local restrictions of movement, you do not enter or withdraw your entry if these restrictions have been imposed after entering. Entry fees will be returned.

If you are uncertain about any of the above measures, please do not enter this event.

Online entry and payment only.

Electronic documentation in advance.

Pre-event declaration for signing on, with remote checking of licences possible and possible Motorsport UK verification.

Pre-event Scrutineering self-declared with external visual checks, and maybe remote internal checks on the day.

With legislation and guidance changing regularly, having to cancel the event is always possible.

#### **DURING** the Event

A dedicated Covid-19 Officer will be present to ensure that these measures are adhered to.

All present must comply with any request from the Covid-19 officer.

Only the driver or crew are allowed on the site – no spectators, no mechanics and no friends will be permitted. This is to ensure that the list of people present is full and complete in order that Test & Trace can be implemented if needed.

Prospective competitors must agree to the following:

Comply with the anti-social social distancing of 2 metres at all times.

In the paddock area, face masks will be compulsory at all times for all attendees except when eating or drinking. The mouth and nose must be covered by a tightly-fitting covering, particularly with regard to the sides of the nose. Care must be taken when removing all facial coverings, in line with Government guidance.

For competitors, when walking the hills face masks are recommended but not compulsory providing a 2 metre anti-social distance from others can be maintained.

For marshals, face masks are not compulsory when on hills unless a 2 metre anti-social distance from others cannot be maintained.

When occupying a vehicle either alone or with a household member, face masks are not compulsory.

During the event, only the crew members may sit in or move the car.

Permanent toilets with hand sanitisers will be available.

Hand washing facilities and a sanitising station will be available.

#### AFTER the Event

If any attendee on the day feels unwell with possible Covid-19 symptoms or tests positive for Covid-19, they MUST contact the organisers so that they can alert other attendees of the situation. Track, Test and Trace.

- 2 The meeting will be held under the General Regulations of Motorsport UK (incorporating the provisions of the International Sporting Code of the FIA), these Supplementary Regulations & any written instructions that the organising club may issue for the event.
- 3 Motorsport UK event permit number 119704 has been issued.
- **4** The event is open to:
  - a) All fully elected members of the organising Club.
  - b) All fully elected members of the BTRDA.
  - c) All fully elected members of the Cotswold MSG Competitors Club.
  - d) Registered contenders in the AWMMC Car Trial Championship.
  - e) Registered contenders in the ASWMC Car Trial Championship.
  - f) Registered contenders in the WAMC Car Trial Championship.
  - g) Motorsport UK British Car Trial Championship contenders.
- 5 If requested, all drivers and passengers (if fitted, and except as in T4.1.7) must produce a valid Club Membership Card and a valid 2021 Competition Licence of RS Clubman status or above. Championship Contenders must also produce their Championship Registration Card, where appropriate.
- **6** The event is a round of the following championships.

7 The programme of the meeting will be:

Signing on and Scrutineering start at 0815

Any competitor **not signed on** by **0945** may be excluded.

First car starts at 1000.

**8** The events will consist of four classes as follows;

#### 1) Two Wheel Drive PRODUCTION CARS - CARRYING NO BALLAST

Two wheel drive production cars, first registered on or after 1st January 1998, taxed for road use, carrying no ballast and having no modifications save as follows. : (a) the fitting of underbody protection weighing no more than 10kg (including fittings); (b) the replacement of wheels in accordance with Regulation T 11.12; (c) the replacement of tyres in accordance with Regulation T 11.12.5. Page 2 Class 1, cont. Minimum tyre pressures on driven wheels: (see Notes 1 & 2) FWD cars: up to 1,200 cc: 12 psi up to 1,400 cc: 14 psi over 1,400 cc: 16 psi FE RWD cars: 12 psi RE cars: 20 psi

#### 2) Front Wheel Drive PRODUCTION CARS

Front wheel drive production cars, not eligible for Class 1. Minimum tyre pressures on driven wheels: (see notes 1 & 2) Up to 1200cc = 12psi, up to 1400cc = 14psi, over 1400cc = 16psi.

#### a) Rear Wheel Drive PRODUCTION CARS and PRODUCTION KIT CARS\*

Rear wheel drive production cars not eligible for Class 1. These cars must have an overall first gear ratio which is numerically less than 17:1 and conform to Car Trials regulation for tyres T11.12.6.

Minimum tyre pressures on driven wheels: (see note 1)

FE Sports cars up to 1800cc = 16psi, FE Sports cars over 1800cc = 22 psi,

FE Saloon cars up to 1800cc = 14psi, FE Saloon cars over 1800cc = 20psi,

Rear Engined cars up to 1000cc = 22psi, RE cars over 1000cc = 26psi.

\* Production Kit Cars are not eligible for T 11.12 and must only use wheels of the sizes detailed in their MSUK specification which can be found in the Motorsport UK online Resource Centre. Production Kit Cars must comply with T 11.12.5 to T 11.12.8.

#### **AND**

#### b) MODIFIED PRODUCTION CARS AND MODIFIED KIT CARS

Cars (not eligible for Classes 1 or 2) complying with Motorsport UK Regulation T 10 Classes 1-6 and 7 (b) and front engined Kit Cars modified beyond Car Trials Formula regulations and up to the limits specified in T10 Class 7 (c), and with the ACTC approved specification readily available for inspection. T 10.1 may not apply as MOT is not required when off road. The Car Trials Wheels and Tyres regulations T 11.12.5 and T 11.12.6 must be complied with.

• Modified Production Cars (not eligible for Classes 1 or 2) complying with Regulation T10 (except for T10.1 – MoT not required off-road) and modified no further than the limits specified in Regulation T10 (Classes 1 - 6).

Minimum tyre pressures on driven wheels: FWD Cars 16 psi FE RWD Cars 22 psi FE Kit Cars 24 psi RE Cars 26 psi

#### 8) NON-PRODUCTION CARS in Clubman event only

(2 wheel drive cars modified beyond Regulation T11, modified no further than the limits specified in Regulation T10 Class 8 and complying with Regulation T10) (except for T10.1 – MoT not required offroad).

Minimum tyre pressures on driven wheels: (see Note 1) FWD cars = 22 psi, FE RWD cars to ACTC Specification = 22 psi, FE Kit cars = 24 psi, RE cars = 26 psi

- Notes 1). Any car fitted with a torque biasing differential or any other mechanical form of traction control as catalogued for that car, will have tyre pressures set at 4 psi above the specified class pressure. Any car fitted with an unmodified original equipment electronic traction control system will be allowed without the 4psi tyre pressure penalty
  - 2). Cars with an overall length of 166 inches and over in Classes 1 and 2 may reduce the minimum tyre pressures by not more than 4 psi, subject to an absolute minimum pressure of 12psi.

Classification of any vehicle in the event will be at the discretion of the organisers. All vehicles must comply with Motorsport UK Technical Regulations. Vehicles in Class 8 will not be eligible for Overall placings.

- **9** Public roads will not be used to link sections. There will be at least twenty three sections on private land. Details of the sections will be issued at signing on. The entry may be split into groups starting at different hills.
- 10 Entries open on the publication of these Regulations, and close finally at noon on Tuesday 22nd June. All entries must be made on line through the Club's website entry system on the Wye Valley Car Trial page. The entry fee must then be sent by PayPal following the link on the Wye Valley Car Trial page OR being paid by BACS to the Club Account.

  Entries will be automatically acknowledged by e-mail once the form has been completed satisfactorily, and accepted by e-mail only on receipt of the entry form AND payment. The entry fee for the event is £39, or £30 for drivers under the age of 18.

- The maximum entry for the meeting is fifty. The minimum is twenty. Should the minimum figure not be reached, the organisers reserve the right to cancel the meeting; all entry fees being refunded in full. There is no minimum class entry, and entries will not be amalgamated except for possible award purposes only. Entries will be selected in order of receipt, the running order being decided by ballot after 1800 Friday 25th.
- 13 Awards will be presented as follows:-

First Overall (On Index).

First in each Class (subject to 3 starters).
Second in each Class (subject to 6 starters).
Third in each Class (subject to 10 starters).

First Novice (On Index) (subject to 3 starters).
First Ross (On Index) (subject to 3 starters).
First BTRDA Member (On Index) (BTRDA Crested Spoon).

A Novice is defined as a competitor who has not won a class award on a Car Trial in the last 5 years.

In line with Motorsport UK recommendations, the Club have appointed a Club Safeguarding Officer. Carol Morgan may be in attendance or can be contacted on 07882 665989. Our Data Protection Privacy Notice is on our Club website.

- 15 For the purposes of T7.3, "The Finish" is when the competing car completes their attempt at their last scheduled hill of the day. Provisional results will be published as soon as possible following the end of the event and declared final as D26.1 viz after 30 minutes. Awards will be presented.
- 16 Any protest must be lodged in accordance with C5.
- 17 Competitors will be identified by numbers which will be supplied by the organisers. They must be displayed in a prominent forward facing position.
- 18 Marking and penalties will be as printed in the appropriate section of Motorsport UK General Regulations except T7.5(a) time penalty & (c) restarts.
- 19 The event may contain some sections with a restart. This will be indicated by a pair of posts with an 'R', on either side of the section. Competitors will be required to stop their car astride this line. Once stopped, with the handbrake applied, the restart marshal will lower their flag and the car will be required to restart. The car should clear the line with its rear wheels within ten seconds of the flag being lowered and continue up the section in the normal way. The penalty for failing to stop astride the restart line, or failing to restart within the time, will be the same as if the car had stopped in that position if there had been no restart present.
- 20 All other General Regulations of Motorsport UK apply as written, except that:
  - a) D17.1 One vehicle may be entered by not more than two drivers. In such case, the responsibility of entry shall be shared by the two entrants.
  - b) No practicing near the hills will be allowed. In addition, the driving of a competing vehicle, other than by a competitor, before the event, during the lunch break, or after the event, anywhere near the competitive hills is not covered by the event insurance and will not be permitted. It is the Entrant's responsibility to ensure compliance with the above. A penalty of 50 marks will be applied to the one or both (if two) nominated driver(s) of the car so used.

c) T4.1 Passengers need not be carried in cars; but if this option is taken, then no passenger can be carried in that car on any hill.

#### d) TYRE REGULATIONS:

The following variations to Motorsport UK Regulations apply to all Classes and cars:

- T 11.12.6 Use of the following tyres is prohibited:-
- (1) those having any of the following patterns, inscriptions or manufacturers' designations:- 'All Seasons', 'Grip', 'Snow', 'Special Use', 'Town & Country', 'Mud & Snow', 'M+S', 'M.S.', 'M&S' or the Three Peaks Mountain Snowflake symbol;
- (2) those constructed primarily for off-road use;
- (3) those having additional grooves intentionally cut into the tread pattern (post manufacture);
- (4) Goodyear All Weather Steel Radial, Goodyear Vector, Pirelli P7, Michelin XRN or Uniband Rally Steel;
- T 11.12.6.1 Tyres must comply with Regulation L 2.1.
- e) T1.2 As the event takes place wholly on private land, cars need not be taxed or insured for the public road, except Class One cars.
- 21 All marshals are deemed to be judges of fact regarding marks lost and any restart penalties on the sections. The marshals' signing on sheet will be displayed at the signing on area before the start of the competition.
