Supplementary Regulations

- 1 The South of Scotland Car Club Ltd. will organise a Clubman status autotest on Sunday 17th July 2022. The event will be held at Lockerbie Lorry Park , Johnstonebridge , Lockerbie , Dumfries DG11 2SL
- 2 The meeting will be governed by the General Regulations of the Motor Sports Association Ltd (Incorporating the provisions of the International Sporting Code of the FIA), these supplementary regulations and any written instructions that the organising club may issue for the event.
- 3 MSA permits : Clubman 127094
- 4 The event is open to:
 - a) registered entrants in the 2022 Link-up Ltd. Motorsport UK Autotest Championship, the Demon Tweeks Direct BTRDA Autotest Championship, the BTRDA Allrounders Championship
 - b) members of organising club and registered contenders of Scottish Championship

5 All competitors must produce a valid MSUK competition licence a club membership card and a championship registration card if applicable.

6 The programme for the event will be:

9.00 am - Noise test, Scrutineering and Signing on.10.00 am - A drivers briefing.10.15 am - The first test will start.

Lunch Break There will be a 30 min break between Morning and Afternoon rounds

2.30pm – Approx - The event will conclude3.00 pm – Approx. , Prize Giving completed, allowing everyone an early and safe departure.

7 The event will consist of five classes as follows:

- Class A Saloon cars under 11' overall length Including Mini saloons with non mini engines
- Class B Saloon cars over 11' overall length
- Class C Sports cars and Sports kit cars
- Class D Specials

Class E Road going series production cars

Note Class E, All vehicles in this class must be capable of being driven on the road.

They must be taxed and have a current M.O.T. Certificate (if applicable) which will be checked at signing on.

8 The awards for the event will be presented on site at competition venue as follows:

Morning

FTD an Award of Immense significance demanding phenomenal jealousy and Rapturous applause 1st in each class an award of a Loud envious applause 2nd in each class an award of a Pat on the back

- 3rd in each class an award of a Pinched cheek

Afternoon

Last Man Person standing : Remainder of Rapturous applause and Envious Gift Other Person : First Loser pat on the Back

No competitor may win more than rapturous applause (per round Am / Pm). Additional applause may be presented at the clubs discretion.

13 Provisional results will be on display during the event and as soon as possible following the conclusion of the event. Any protests must be made in accordance with Section C, otherwise the results will be made final and the awards will be presented at the event location once result finalised.

14 Practising will **NOT** be allowed and competitors will **NOT** be allowed to walk on the tests once the event has started.

15 Test diagrams will be added to the final instructions and will be available on the SOSCC website from 14th July We will have two identical tests constructed

The morning format is to have 5 runs at test A and B (total 10 runs)

The Afternoon format is to use tests A & B as an eliminator (Min 2 Runs !) Lowest combined times progresses

To keep the event flowing we would ask all competitors to be ready to start the test within 30 seconds of arriving at the start line.

Morning Format Competitors will start in their own time Afternoon Format Both Competitors will start with visual instruction

If you chicken out or suffer a mechanical breakdown then please inform the Clerk of the Course who will arrange for you to slot back into the running order where / if possible.

Competitors MUST run in order, unless permission is granted by the Clerk of the Course. In the interests of safety, any competitor failing to stop astride the finish line, and / or before the baulk line following the finish line, **will** be penalised 5 seconds for **each offence**.

16 The General Regulations of the MSA apply as written, except the following which are modified

A vehicle may be entered by two different competitors

M.4.2 Pylons may be less than 1 metre high

Table M.7.c. 20 seconds

Table M.7.c 5 seconds

In any test diagram illustrating a test, dimensions will be approximate and only for guidance. Indications of the direction of travel of the competing car when crossing a line, passing between markers will be mandatory but not exclusive (ignoring shunts to avoid markers) A maximum penalty will be applied when the mandatory sequence of manoeuvres has not been correctly completed. A test will not be deemed incorrect if the driver realises their mistake, returns to the point at which the mistake occurred and then completes the test correctly as required by the test diagram.
